

MUNICIPAL ORDINANCE NO. 16-06-2011

AN ORDINANCE CREATING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE AND ITS OFFICER AND TRANSFERRING ITEMS/POSITIONS CREATED UNDER MUN. ORD. NO. 13-04-2004

Be it ordained by the Sangguniang Bayan of Tukuran, Zamboanga del Sur assembled and constituting quorum to promulgate the following ordinance:

- Section 1. Creation of Office. The Office of the Municipal Environment and Natural Resources is hereby created in the Local Government Unit of Tukuran, Zamboanga del Sur.
- Section 2. Creation of Position. The level 2 position which is Municipal Environment and Natural Resources Officer I his hereby created with a salary grade of 24.
- Section 3. Qualifications. In addition to the qualifications as stated in the Qualifications Standard of the Civil Service Committee and the RA 7160, no person shall be appointed to the position created in Section 2 hereof unless he/she is a resident of Tukuran, Zamboanga del Sur.
- Section 4. Powers and Duties. In addition to the powers and duties for Environment and Natural Resources Officers as stated in Section 484, Article XIV of RA 7160, per CRM Plan, he/she shall perform the duties, functions and responsibilities of the CRM Manager.
- Section 5. Transfer of Items/Position Created. All positions/items created in Mun. Ord. No. 13-04-2004 (Comprehensive CRM Code) shall be transferred to this office.
- Section 6. Compensation. The positions herein stated shall receive a monthly salary equivalent to their respective Salary Grade and such other allowances and emoluments as may be allowed by existing laws and circulars, which may thereafter be included in the municipal annual budget following the approval of this ordinance.

Section 7. Repealing Clause. Any ordinances or parts and/or portion thereof inconsistent herewith are hereby deemed, modified or repealed accordingly.


Section 8. Effectivity Clause. This ordinance shall take effect upon approval of the Municipal Mayor.
