MUNICIPAL ORDINANCE NO. 16-08-2011

AN ORDINANCE REGULATING THE OPERATION OF TRAVELLING RICE/CORN MILL WITHIN THE TERRITORIAL JURISDICTION OF TUKURAN, ZAMBOANGA DEL SUR

Be it ordained by the Sangguniang Bayan of Tukuran, Zamboanga del Sur assembled and constituting quorum to promulgate the following ordinance.

Section 1. Regulated Acts. Operators of Travelling Rice/Corn Mill operating within the jurisdiction of the municipality shall strictly abide by the following:

1. Pay the necessary fee upon securing the Mayor's Permit.
2. The area/site where milling is to be conducted shall be within agricultural or industrial zones of the LGU, and the said activity shall not be done within sidewalks, roadsides and/or road shoulders in order not to pose danger to motorists and other road users .
3. The resultant waste shall be kept and disposed of by the operator in accordance with the local waste management regulations .
4. That the travelling rice/corn mill can operate only at the distance of at least 500 meters away from the stationary rice and corn mill and at least 200 meters away from church and school.
5. Observe other applicable national and local laws.

Section 2. Penalty. Any violations hereof, the operator shall be penalized of a fine of not less than Php 1,000.00 for 1st offense, Php 2,000.00 for 2nd offense and cancellation of Mayor's Permit for 3rd offense.


Section 3. Effectivity. This ordinance shall take effect 10 days from the last day of posting.
