**MUNICIPAL ORDINANCE NO. 16-09-2011**

**AN ORDINANCE FURTHER REGULATING THE OPERATION OF PEDICAB IN THE MUNICIPALITY OF TUKURAN, ZAMBOANGA DEL SUR**

Be it ordained by the Sangguniang Bayan of Tukuran, Zamboanga del Sur assembled and constituting quorum to promulgate the following ordinance:

Section 1. Definition of Terms. The following shall be construed as defined:

Pedicab shall refer to the locally known sikad-sikad.

Section 2. Required Acts. Before a Mayor’s Permit be issued or renewed to a Pedicab, operator/s and driver/s shall be required of the following:

1. The Operator shall install front light in the subject pedicab and should be lighted during night drive and reflector sticker be installed in the back.
2. The Operator shall install garbage receptacle in the pedicab.
3. The Operator shall not engage a minor of 18 years old below to drive a pedicab.
4. The Driver shall not allow to engage minor to drive the pedicab on his behalf.
5. Driver/s shall always wear their Driver’s ID when driving.

Section 3. Penalty.

- A. Any violation in item 1 , 2 and 5 Section 2, hereof the shall be fine in the amount of Php20.00 for 1<sup>st</sup> offense, Php30.00 for 2<sup>nd</sup> offense and Php50.00 for 3<sup>rd</sup> and succeeding offenses.
- B. Violation in Item 3 and 4 Section 2 hereof shall be penalized in the amount of Php50.00 1<sup>st</sup> offense, Php75.00 for 2<sup>nd</sup> offense and Php100.00 for 3<sup>rd</sup> and succeeding offenses.

Section 4. Repealing Clause. Any ordinances or any part/section thereof inconsistent herewith shall be deemed modified accordingly.


Section 5. Effectivity. This ordinance shall take effect 15 days from the last day of posting.

Enacted and approved this 14<sup>th</sup> day of November 2011 during the 69<sup>th</sup> regular session of the 16<sup>th</sup> Sangguniang Bayan of Tukuran, Zamboanga del Sur, Philippines.
